PROFIT WARNING

This announcement is made by Jolimark Holdings Limited (the “**Company**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) and Rule 13.09(2) of the Listing Rules.

The board (“**Board**”) of directors (“**Directors**”) of the Company (and together with its subsidiaries, the “**Group**”) wishes to inform the shareholders of the Company (“**Shareholders**”) and potential investors that based on the preliminary review of the latest unaudited consolidated management accounts of the Group for the six months ended 30 June 2021, the Group is expected to record a loss of approximately between RMB8 million and RMB12.5 million for the six months ended 30 June 2021, as compared with a loss of approximately RMB21.530 million in the same period last year. The decrease in loss is primarily attributable to the increase in total revenue of the Group. The growth in revenue was mainly attributable to the easing of the COVID-19 pandemic and market recovery in 2021.

The information contained in this announcement is only based on the preliminary assessment made by the Board with reference to the information currently available to the Board and such information has not been audited or reviewed by the auditors of the Company. The actual financial results of the Group for the six months ended 30 June 2021 may be different from what is disclosed in this announcement. The interim results of the Group for the six months ended 30 June 2021 is expected to be released before end August 2021. **Shareholders of the Company and potential investors are advised to exercise caution when dealing in the securities of the Company.**
