### **PROFIT WARNING**

This announcement is made by Jolimark Holdings Limited (the “**Company**”) pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong) and Rule 13.09(2) of the Listing Rules.

The board (“**Board**”) of directors (“**Directors**”) of the Company (and together with its subsidiaries, the “**Group**”) wishes to inform the shareholders of the Company (“**Shareholders**”) and potential investors that based on the preliminary review of the latest unaudited consolidated management accounts of the Group for the year ended 31 December 2025, the Group is expected to record a loss of approximately between RMB48 million and RMB55 million for the year ended 31 December 2025, as compared with a loss of approximately RMB60.262 million in the same period last year. The loss was mainly attributable to lower demand in the printer market as a result of the ongoing advancement of the use of electronic invoice, the promotional stage of the medical equipment products and provision for asset impairment.

The information contained in this announcement is only based on the preliminary assessment made by the Board with reference to the information currently available to the Board and such information has not been audited or reviewed by the auditors of the Company. The actual financial results of the Group for the year ended 31 December 2025 may be different from what is disclosed in this announcement. The final results of the Group for the year ended 31 December 2025 is expected to be released before end March 2026. **Shareholders of the Company and potential investors are advised to exercise caution when dealing in the securities of the Company.**
